### WEST COAST DEMERARA TO RUIMVELDT ROAD IMPROVEMENT PROJECT LOT 1 & LOT 2

The Government of Guyana and Caribbean Development Bank on sole source basis awarded Lot 1 West Coast Demerara by upgrading from 2 lane/2 way to 4 lane/2 way and rehabilitation of 6 km of the West Coast Demerara Road, and new bridges Lot 2 East Coast Rehabilitation Project is funded by the Caribbean Development Bank and estimated construction cost for two Lots is US \$ 19 million including the extension of Road to proposed World Cup Cricket Stadium in Providence

### REHABILITATION FEASIBILITY STUDY -CONSTRUCTION MAHAICA-ROSIGNOL ROAD

The Government of Guyana selected SNC-Lavalin International Inc. to undertake Construction Supervision for the 66-km rehabilitation of existing Mahaica – Rosignol Road plus 4 km by-pass. Works included Construction of drains, road, road lighting, culverts etc.

### SOESDYKE - LINDEN HIGHWAY REHABILITATION AND RECONSTRUCTION PROJECT

SNC-Lavalin International Inc. was commissioned by the Ministry of Public Works and Communications to review the design and carry out the Construction Supervision for the Rehabilitation of 70 kms of Soesdyke-Linden Highway of the existing road from Georgetown to Linden. Additional 7 km of street construction in the City of Linden was added to the project scope before completion of the works.

### WEST COAST DEMERARA TO RUIMVELDT ROAD IMPROVEMENT PROJECT

The Government of Guyana's project objective was to solve the traffic congestion problems along the southern approach of the existing 4 km East Bank Demerara Road from Demerara Harbour Bridge to Georgetown by upgrading from 2 lane/2 way to 4 lane/2 way and rehabilitation of 40 km of the West Coast Demerara Road with additional 9 km of road from Parika Junction to Backdam. Project is funded by the Caribbean Development Bank and estimated construction cost was US \$ 18 million

#### NEW AMSTERDAM/MOLESEN CREEK ROAD REHABILITATION PROJECT

The contract comprised of the rehabilitation of the New Amsterdam to Moleson Creek Road along the East Coast of Berbice, Guyana. The contract was divided into two sections, Lot 1 and Lot 2. Lot 1 - Located between Km 0+ 000 at the beginning of New Amsterdam's Stelling Road to Km 41+100 at No. 36 Village Corentyne, East Berbice. Lot 2 - Located between Km 41+100 at No. 36 Village Corentyne to 86 + 400 which is at Moleson Creek Corentyne, East Berbice. The extent of the contract was the rehabilitation of carriage way, shoulders, drainage system, structures and road furniture of the project defined in the specifications and contract drawings.
